Dear Parents

We are really excited to offer this twilight camp experience to your son. We have many adults that have stepped forward to give a hand in running a program that should be exciting and fun for all of the campers. But we do need a little help from you.

- * When you drop off your son for the camp, please be considerate of where you park your car. The camp is being held in a neighborhood park and we do not wish to irritate or otherwise bother the neighbors.
- * Please sign your camper in and out with their den leader. The camper will not be released to anyone who is not one of the approved pickup persons that you listed on your application. If you want a new person on the approved list, please fill out a short form that the den leader or registrar will give you.
- * We understand that emergencies happen. If you or the person listed to pickup cannot make it, please call to tell us the person who will be approved to pick up your child. Also, if your son needs to leave the camp earlier than the 8:00 pickup time, please inform your son's den leader or the Registrar.
- * Please make sure your son has any medication he needs in the care of the camp medic.
- * Please make sure your son is wearing closed-toe shoes, has a non-perishable dinner and a supply of water. There will be water for refills but no containers. Have him wear his camp shirt and hat each day.
- * There will be a short closing ceremony on Friday evening at 7:30 pm. All parents are welcome to attend. The camper will be given a paper with the requirements of rank that he may have earned and also any other awards he may have earned.
- * Drop-off time is no earlier than 3:50 pm. Pick-up must be no later than 8:00 pm. Please be prompt. Please call if there is a problem picking your son up or if your son can't make it to the camp for that day. We will be calling to verify his absence.
- * If camp must be cancelled, or there are other schedule changes you will be notified as quickly as possible. Please make sure that all of your contact phone numbers are correct and that we have the best number to get a hold of you in case of an emergency.
- * Parents are always welcome to visit the camp. Just please make sure you sign in with the Registrar or Camp or Program Director.
